The Medical Practitioners Coalition Association of Malaysia is perplexed to note that while we have people in the public sector shunning available vaccines, we, in the private sector, especially private primary care facilities, have been turning away clients who want to be vaccinated. For the past six months, general practitioners have not been able to get vaccines and have had to refer those who need to be vaccinated to government hospitals and health clinics because of what we have been told is a “global shortage”, due to a stop in production by one of the two major suppliers based in Europe. The vaccines concerned are the Diphteria, Tetanus and Pertussis (DTaP), the Hib vaccines, the polio vaccines and more recently, the Hepatitis B vaccines. We hope that with the sudden severe shortage, the Health Ministry can issue a temporary import licence for suppliers to import these vaccines from other countries such as India, to cope with the demand in the private sector.
